<p>Postal Code Address Data – A list of all the postal codes in the country and the range of addresses associated with each one.</p>		
<p>Delivery Mode Data – Provides all the information you need to presort your mail and get the best price for your mailing. The file contains postal codes and their related delivery modes.</p>		
<p>Householder Data – Indicates the number of houses, apartments, farms and businesses within an area defined by the first three characters of a postal code (forward sortation area or FSA). The list is also broken down by the routes the letter carriers follow to deliver the mail.</p>		
<p>Householder Elite Data – Indicates the number of houses, apartments, farms and businesses within an area defined by a complete postal code. The list is also broken down by the routes the letter carriers follow to deliver the mail, including all the information you need to send by mail using Canada Post Electronic Shipping Tools (EST).</p>		
<p>Postal Outlet Data – Outlines all the postal outlets that are open, closed or amalgamated in Canada, with their respective serving delivery installation.</p>		
<p>Postal Code Latitude/Longitude Data – Allows organizations to determine geographic coordinates at the postal code level. It also includes the number of houses and apartments served by the postal code in a supplemental file. For rural areas (where available), the centroid (centre point) is identified at the town or city level (internal use only).</p>		
<p>Postal Code Conversion File – Provides a link between six-character postal codes and standard census geographic areas (i.e. dissemination areas, census subdivisions, census tracts). This product was not designed for the purpose of validating postal codes. Annual and Quarterly distribution is available.</p>		
<p>Postal Code Conversion File Plus (+) – A SAS® control program and set of associated datasets derived from the PCCF and other supplementary data. The PCCF+ differs from PCCF in that it uses populated-weighted random allocation for postal codes that link to more than one geographic location.</p>

Postal Code Federal Riding File – Provides a link between six-character postal codes and Canada’s federal electoral districts (FEDs). A FED is any place or territorial area entitled to return a member of Parliament (MP) to service in the House of Commons and is commonly referred to as a federal riding. Annual and Quarterly distribution is available.

Point of Call Data – The most comprehensive address database available in Canada, with more than 14 million points of call (addresses). This is a premium product with a master address key (unique identifier) for each individual address that does not change.
